Applicants should be prepared to describe one or more project ideas related to protecting elders, workers' rights, or consumers' rights through impact litigation or policy.

### **ESSENTIAL DUTIES**

Under the supervision of Bet Tzedek staff, the fellow will:

- Help develop, conduct, and/or co-counsel strategic impact litigation
- Conduct legal research and analysis, and analysis and track proposed legislation
- Work with Bet Tzedek staff and community partners to identify systemic problems impacting Bet Tzedek's clients that could be addressed through affirmative litigation or policy
- Develop trainings and informational materials for other practitioners and community members.

### **QUALIFICATIONS**

- Membership in the California bar or ability to practice under CA Rule of Court 9.45 by August 2020 (strongly preferred), or completed the CA bar exam by August 2020 (required)
- Excellent research and writing skills
- Ability to work independently and collaboratively
- Demonstrated commitment to anti-poverty and social justice work, and to serving low-income community members with compassion and respect.
